PTProvider vs. PTAgent

WHAT IS THE DIFFERENCE BETWEEN A PTPROVIDER AND PTAGENT?

PTProvider

A WELL PTProvider is an organization, approved by IWBI via an application process, that employs one or more trained WELL PTAgents

PTAgent

A WELL PTAgent is an individual who has attended a WELL PTAgent training

Note: WELL PTAgents must be employed by a WELL PTProvider to conduct onsite performance testing for WELL projects

Performance Testing Agents cannot provide onsite testing services for WELL – they must be employed by an IWBI -approved Performance Testing Provider.

PTProvider - minimum requirements

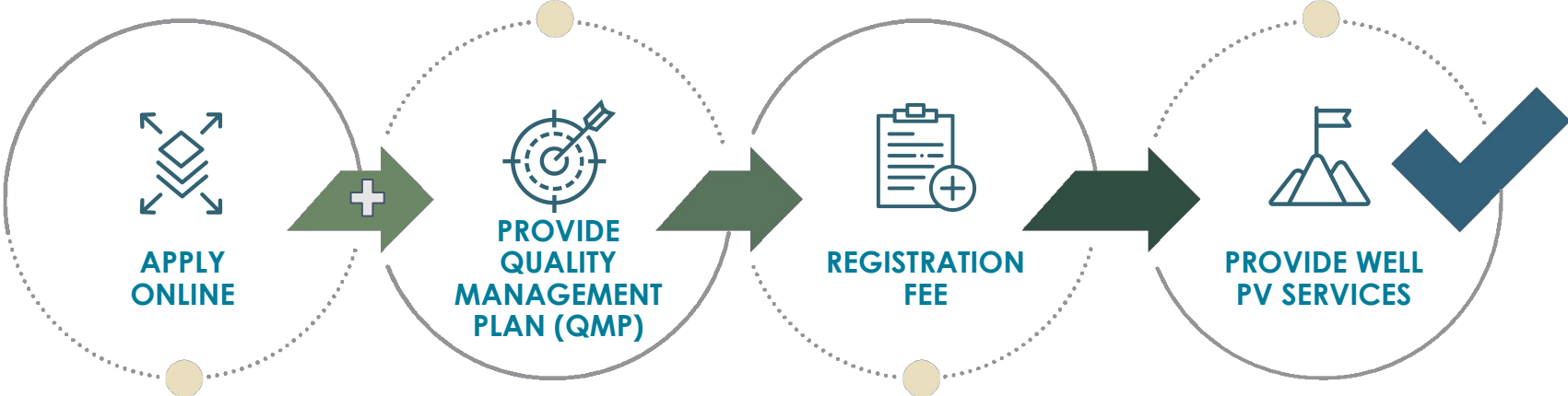
Interested organizations must submit an application demonstrating the following requirements are met:

- Employment of one or more individuals who have completed the [WELL Performance Testing Agent Training](#).
 - Full name and date of training are needed to confirm PTAgent status.
 - **At least one PTAgent must have prior onsite testing experience in one or more of the WELL Concepts.**
- Employment of one or more individuals who are a [WELL AP](#) in good standing.
 - Full name and WELL AP# are needed to approve WELL AP.
 - IWBI recommends that the PTAgent and WELL AP are two different individuals.
- Establishment of an internal quality management plan (QMP) meeting the [Performance Testing Quality Assurance Manual](#). Please reference [this QMP guide](#) when developing your QMP. A finalized QMP must be submitted as part of the application for review and approval by IWBI.
- Acceptance of terms and conditions (included in the PTProvider Application Form).
- Payment of PTProvider enrollment fee (\$6500) upon IWBI's acceptance of the application.

PTProvider - application process

Meet minimum requirements to apply. The application includes basic organization information, PTAgent & WELL AP info, company logo, and QMP.

After your application has been approved and once you have paid the enrollment fee, your organization will be displayed in our directory.



At the time of application, a QMP is required, providing specifics on trained testing agents and how quality will be ensured within your organization.

All WELL Performance Testing Providers must meet the below requirements. IWBI will review your application to confirm your organization meets the below requirements. Upon confirmation, approval will be granted. Upon approval, your enrollment fee will be due. Your WELL PTProvider status will become active upon payment of the enrollment fee. In order to maintain your status, PTProvider renewal fees are due annually, beginning one year from the date of the enrollment invoice payment.

IWBI is prioritizing applications from organizations who meet the minimum requirements (listed below) and the following criteria:

- The provider has a trained PAgent located in underserved regions which have one or fewer agents
- The provider has existing clients awaiting onsite testing services and can provide the registered project name and ID

Minimum requirements:

- Employment of one or more individuals who have completed the IWBI WELL Performance Testing Agent Training.
 - Full name and date of training are needed to confirm PAgent is in good standing.
 - PAgents must have prior on-site testing experience in one or more of the WELL Concepts.
- Employment of one or more individuals who are a [WELL AP](#) in good standing.
 - Full name and WELL AP# are needed to confirm WELL AP status.
 - IWBI recommends that the PAgent and WELL AP are two different individuals.
- Establishment of an internal quality management plan (QMP) meeting the requirements of the [Performance Testing Quality Assurance Manual](#). Please reference [this QMP guide](#) when developing your QMP. Your finalized QMP must be submitted as part of this application for review and approval by IWBI.

Annual renewal requirements:

- Continue to meet minimum requirements
- Completion of [renewal survey](#)
- Payment of renewal fees
 - Renewal fees are based on the total square footage of projects served by your organization in the previous year and are to be paid by the anniversary of the enrollment year's payment date

All WELL Performance Testing Providers will be charged an annual renewal fee, on the anniversary of the enrollment year's payment month, based on the total square footage of projects served by them in the previous year. This fee will be calculated based on the structure outlined below.

Please note that individual projects less than 50,000 ft² (4,645 m²) will not be included in the calculation used to determine the fee thresholds. If the total square footage served of the project is over 50,000 ft² (4,645 m²), it will be factored into the renewal fee calculation, regardless of the project type.

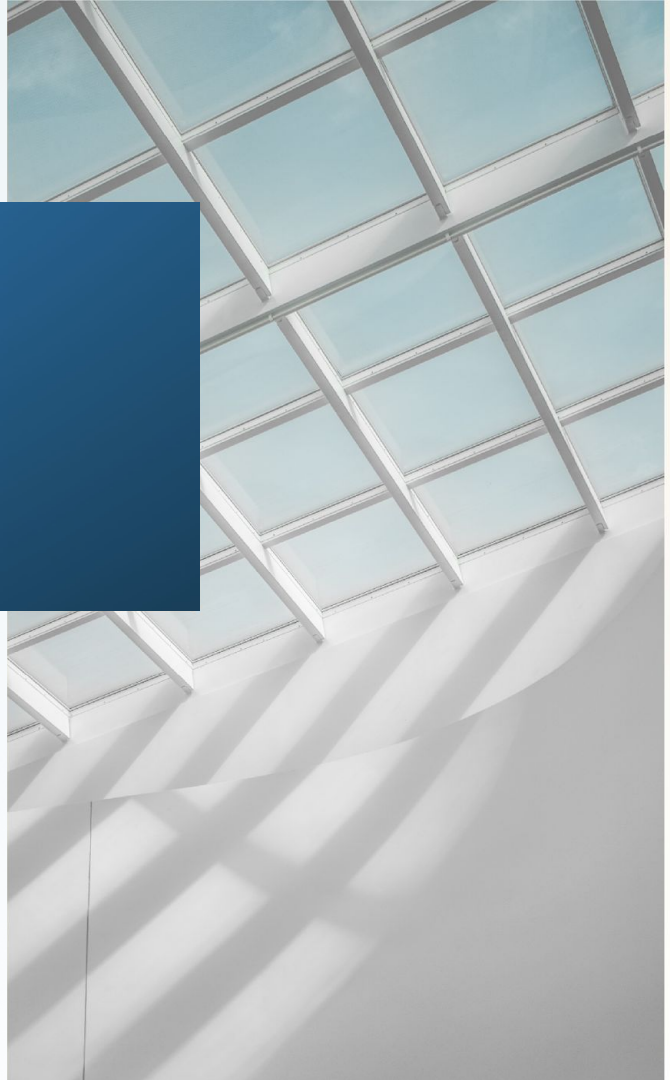
Maintain PTAgent designation

Annual renewal requirements:

- Must work for a PProvider meeting the minimum requirements.
- Renewal will be every two years from the year they attended their initial PTAgent training (date can be found on certificate of completion). For example, an individual who attended the PTAgent training on July 9-11, 2023, will need to renew by December 31, 2025.
- PTAagents are required to renew their status every two years by attending a live PTAgent training, available to these renewing agents for \$500. Or, if a PTAgent (as a staff member of an approved PProvider) serves on a project within the year leading up to their renewal year, we will allow an exemption from participating in a live PTAgent training.

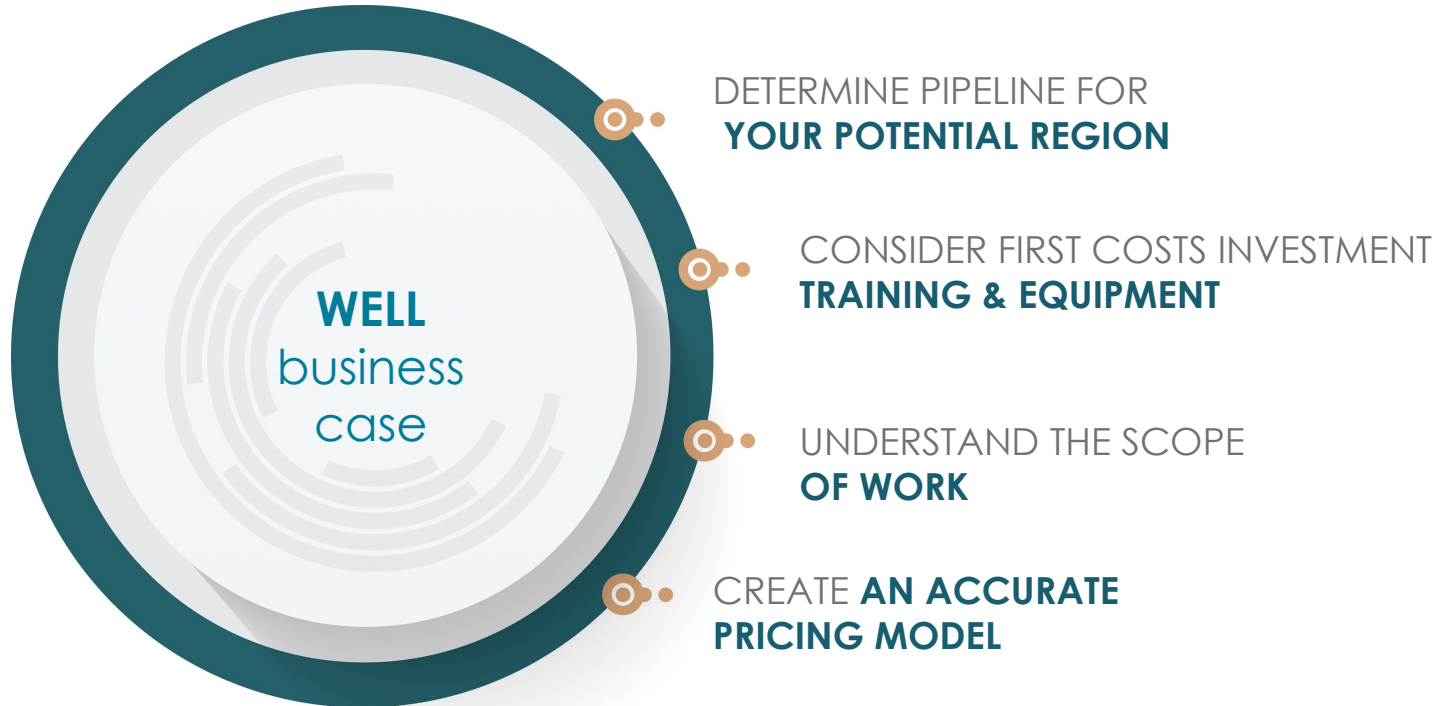

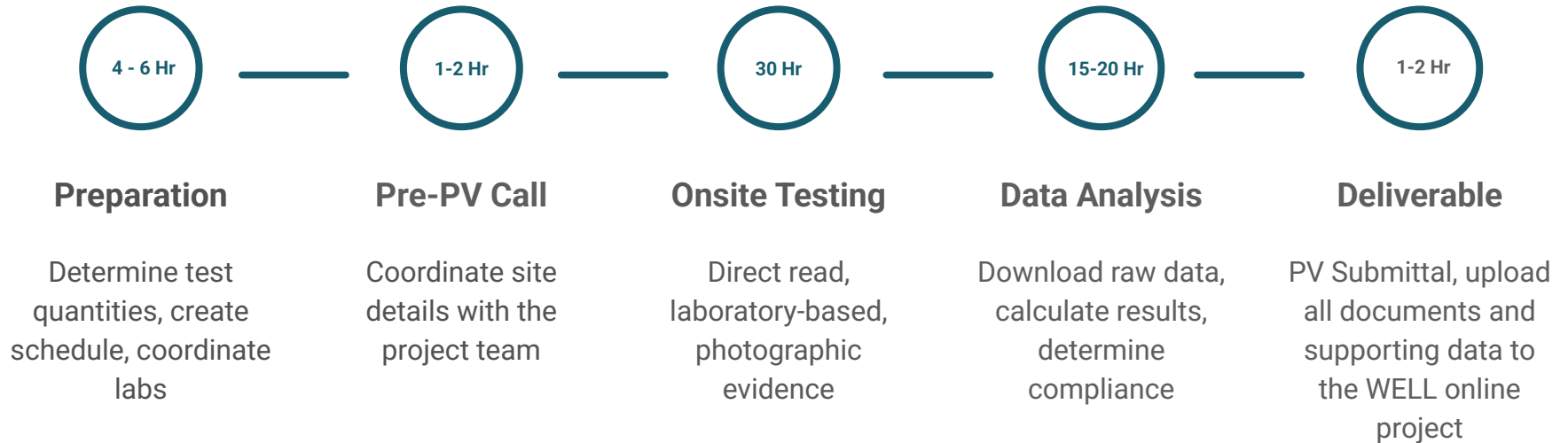
Feature / Parameter	Time per location	Notes
Air - PM2.5, PM10, CO, O3, NOx	75 min	Direct-read device (simultaneous to laboratory collection)
Air – TVOC, Formaldehyde	75 min	Laboratory (simultaneous to direct read air)
Water – turbidity, chlorine, residual chlorine	10 min	Direct-read device (sequential to laboratory collection)
Water – disinfectants	30 min	Laboratory (sequential to direct-read measurements)

Average time for each test

Feature / Parameter	Time per location	Notes
Light – lux, EML	1 min	Direct-read device (sequential with some locations usable for both)
Thermal – temperature, humidity, dry bulb temperature	15 min	Direct-read device (simultaneous measurements across parameters for each location)
Sound S02 – background noise	10 min	Direct-read device (sequential to other Sound measurements)
Sound S03 – sound barriers	30 min	Direct-read (sequential to other Sound measurements)
Sound S04 – reverberation	15 min	Direct-read (sequential to other Sound measurements)
